Presidents Report from the 2018 USATF Annual Meeting.

SafeSport:

-On January 3, 2018, nearly unanimously, Congress passed "Protecting Young Victims from Sexual Abuse and Safe Sport Authorization Act of 2017." President Trump signed the bill into law on February 14, 2018. The new federal legislation mandates certain protections for young athletes, especially in cases of sexual abuse accusations.

- -USATF has a three step procedure to help insure our athletes are protected from predator abuse. To be a club coach/volunteer for a USATF Nebraska sponsored club, you have to:
- 1. become a member of USATF
- 2. pass a background check
- 3. be SafeSport approved; watch the SafeSport video and pass an information test

-Implications for USATF Nebraska Clubs

- 1. All volunteers working directly with children at club practices have to be SafeSport approved.
- 2. Occasional volunteers at Association Championships have to present a photo ID and sign a SafeSport Waiver.
- 3. Volunteers at club meets do not have to be SafeSport approved.

-Information to digest in this "new age" of protecting our children from abuse.

- 1. Only four percent (4%) of abuse perpetrators are the "Stranger Danger" characters, ninety-six percent (96%) are someone you know and trust, someone who looks and acts like you; relative, friend, neighbor, coach, teacher, priest/minister, daycare worker.
- 2. Grooming begins with the adults, then moves to the children. The perpetrator first works to earn the trust of adults responsible for the care and safety of the victim.

Coaches Registry:

-The Coaches Registry is a list of USATF coaches who have attained a minimum level of coaching education. Club coaches do not need to be on this list in order to coach. The advantages of being on the Registry are free entry at Regional and National meets, and access to coaching areas at these meets.

PARA ATHLETICS COMMITTEE

The Paralympics have always been a stand-alone entity, much like the deaf and hard of hearing community or Special Olympics. However, there is a push by the para athletes to be included with USATF. In order to "introduce" themselves to the USATF community they asked to be able to hold workshops at the Annual meeting. With this being granted, , a small select group of people attended two workshops at this year's annual meeting to engage, learn, promote and educate attendees. The para community along with interested attendees sat in two workshops to create the Para athletes sport committee's mission statement, vision statement and determined the committee's core values. I attended both of these workshops as well as the workshop on officiating Paralympics.

There is a need for more Paralympic officials in USATF. There was a course given in one of the breakout meetings. The course is a PowerPoint presentation which gives a link to the open book test (25 questions). You may take this test on your own, as long as you are at least an active Association level official. USATF Convention - November 2018, Columbus OH

I attended the officials meetings – below are the highlights:

Law and Legslation – this was an off-year so there was not really anything to change this year. The Board of Directors is focusing on making sure that bylaws are not changed on a whim because of anyone's personal agenda.

Also discussed regulation 21 on grievances – bottom line is that all associations need to make sure that they have a clear grievance policy.

Officials Training – they have created officials training videos to be stored in an online library for all to use. Videos will range from introductory lessons, to refresher courses to advanced training. The project is pending approval from the USATF attorneys regarding licensing and branding(and has been pending for about 2 years). If the process is delayed too much longer, they may remove branding and just upload them to Youtube..

Also new in this area is the proposal of safety training for all officials. It will become part of the certification process and done similarly to the safe sport training.

Quick reference guide (QFG) flip books were handed out. The pdf's are online as well for associations to have coped at their own expense if they choose.

Para – Athletics – all states should have officials take the online training and be prepared and knowledgable as associations and meets become more inclusive.

Testing – Rules review and testing is going to move to be online rather than using a paper test. Paper will still be available for those who choose it. Tests up to Masters level will be autoscored and sent to certification chairs. Master level tests will have some questions that cert. chairs will have to manually check and approve. Process should be ready by July 2020.

Rules – no big changes this year, just a few to help align with NSAA. New rules books will be out in March.

Other info: They are assigning national meets. Average age of officials participating is 61.2, which is 2 years younger than a year ago. They are working on developing consistencies at all levels for officials (Pay, rules, etc).

Officials have submitted a proposal to have a separate website from USATF so that they can upload their own info quicker and have more control over the officials database.

2018 Annual Convention Men's & Women's Track and Field Report

The largest area of change to Men's & Women's Track and Field is to the IAAF ranking system for athletes to qualify for world and Olympic competition.

https://worldrankings-staging.aws.iaaf.org/world-ranking-rules/basics This link provides insight into how the rankings are now devised.

Since the 2018 Annual convention, there has been considerable push back to the IAAF, that the ranking system is not equitable in how points are awarded to meets. The USA's argument is that the NCAA Division DI Championship meet regularly produces exceptional marks more so that marks from meets in a host of countries outside the United States borders. The problem is that under the current IAAF ranking system, an athlete would be given fewer total points with the same mark at the NCAA D1 championships versus the total points given for the same exact mark at a country's national championship meet. The USA athletes' opinion is that the proposed IAAF system will need adjustments to be equitable. The goal of the new system is to reward athletes that compete at a high level of competition at several meets of high caliber versus an athlete that has one outstanding mark at a lower caliber meet.

In 2018 the IAAF dissolved all 15 committees to centralize their system. The current IAAF model now has four committees. The author believes that the IAAF will end up with 5-6 mainline committees before 2020.

Additional funding was announced at the annual meeting for Tier 1, Tier 2, Tier 3 and Post college athletes from USATF. In addition, Rose Monday reported in Women's Track and Field that Tier 1 level women athletes will receive USATF support through pregnancy and the follow year after pregnancy.

USA outdoor championships will be held in Des Moines Iowa July 25-28th. Generally, this meet is held 4-5 weeks earlier.
